DECISION

Having reviewed the Complaint previously issued by the Business

Conduct Committee (BCC) in the above-captioned case against Nicholas Charles

Gunther (Gunther), and having considered the Offer of Settlement (Offer) submitted by

Gunther, and having accepted the Offer, the Hearing Panel hereby issues this Decision as to Gunther.

ALLEGED VIOLATIONS OF NFA REQUIREMENTS

On February 4, 2020, the BCC issued a Complaint against Gunther, a former NFA Associate and associated person (AP) of Long Leaf Trading Group, Inc. (Long Leaf), a former introducing broker Member of NFA located in Chicago, Illinois. The Complaint alleged that Gunther, while an AP of Long Leaf, made misleading sales solicitations that exaggerated profit potential; failed to explain the fundamentals and risks of options trading; failed to adequately explain the firm's commission and fee charges or how those charges impacted profitability; and failed to disclose that over

95% of Long Leaf's customers lost money. The Complaint charged Gunther with violations of NFA Compliance Rules 2-2(a), 2-4 and Rule 2-29(a)(1).

OFFER OF SETTLEMENT

Without admitting or denying the allegations of the Complaint, Gunther submitted an Offer in which he agreed to settle the charges against him by agreeing to not apply for NFA membership, or reapply for NFA associate membership, or act as a principal of an NFA Member at any time in the future.

PENALTY

Having considered the matter and having accepted the Offer submitted by Gunther, the Hearing Panel orders that Gunther shall not apply for NFA membership, or reapply for NFA associate membership, or act as a principal of an NFA Member at any time in the future.

This Decision and Gunther's Offer shall not be used as a sole basis for any other action or proceeding by NFA against Gunther, including any registration matter, except they may be used in an action to enforce the terms thereof or in a subsequent disciplinary action or regulatory action, where they may be considered as evidence in aggravation.

IV

INELIGIBILITY

Pursuant to the provisions of Commodity Futures Trading Commission (CFTC) Regulation 1.63, this Decision and the sanctions imposed herein render Gunther ineligible, at any time in the future, to serve on a disciplinary committee,

arbitration panel, oversight panel or governing board of any self-regulatory organization, as that term is defined in CFTC Regulation 1.63.
