# WinJammer User's Guide Filing Notices of Swap Valuation Disputes

(As of October 2, 2018)

# Introduction

WinJammer was designed to facilitate the submission of regulatory filings.

This user's guide will help you navigate through WinJammer in order to submit swap valuation dispute notices. A swap valuation dispute notice filed using WinJammer satisfies your filing requirement with NFA and the CFTC. You should not mail a swap valuation dispute notice to NFA or the CFTC.

# System Requirements

- A currently supported version of Microsoft Edge or Firefox
- JavaScript must be enabled in your web browser
- Cookies must be enabled in your web browser
- 128 Bit Encryption
- Adobe Acrobat Reader

# Initial Login as Security Manager

Please note that your DSRO/DEA/Regulator will have to first set up your firm and provide the security manager with a login ID and password. Contact your DSRO/DEA/Regulator if you have not been provided with an initial Security Manager ID and password.

#### Filing a Swap Valuation Dispute Notice

1. Once your security manager has set up your security for WinJammer you can access the system through the Electronic Filing System section of NFA's website.



### 2. Once on the Electronic Filing Systems Page, expand the Swap Dealers (SD) section.

#### Electronic Filing Systems

Members should use the systems listed below to meet their regulatory filings requirements. To use NFA's electronic filing systems, firms will need to designate a <u>security manager</u>. To ensure Members are able to access the systems, visit the <u>system requirements page</u>.



3. When this section is expanded, you will see links to multiple systems. Click on WinJammer to login to the system.

#### Swap Dealers (SD)

- Access <u>NFA's Online Registration System (ORS)</u> to register with the CFTC and apply for NFA membership electronically. NFA's Dashboard, the entryway to ORS, summarizes periodic filings for firms and outstanding registration filings for firms and individuals.
- Access the Annual Questionnaire, which must be completed annually as part of NFA's membership renewal process.
- Designate an Executive Representative Contact, who has the Member's sole authority to sign nominating petitions, receive notices of
- Member meetings and proxy materials, complete proxy cards, and provide voting instructions and cast votes on behalf of the Member.
- Use <u>EasyFile (RDSS)</u> to electronically file documentation required to demonstrate compliance with Section 4s Implementing Regulations.
   Access <u>WinJammer</u> to file risk exposure reports, notices of swap valuation disputes, Chief Compliance Officer Annual Reports and Business
- Continuity and Disaster Recovery Plan contact information.
   Use <u>EasyFile AP Statutory Disqualification Form Submission</u> to electronically file criminal and regulatory statutory disqualification forms for its associated persons (AP).
- Access EasyFile (Risk Data Filing) to file monthly risk data reports.
- 4. Once in the system, click Sign in to WinJammer.

9. To complete the form for each swap valuation dispute type, either manually enter the applicable values or upload an XML document.

#### Uploading an XML Document

1. To upload an XML document, click Upload from within the filing you just created.

3. To upload a WinJammer swap valuation dispute XML file, the file must validate against the schema for that filing.

5. If the XML is not valid the user will see the below error.



#### Submitting a Swap Valuation Dispute Notice

 After manually entering the required data or uploading and validating an XML file, to submit the filing to NFA and the CFTC, click Review Statement for Errors or click Submit Filing. Note that in order to transmit to the appropriate regulators, they must be on your transmission list.



2. You'll receive a notice of error or warning if any exist. You must address these errors by opening and updating the filing before you may submit.

### Filing Amendments for Notices of Swap Valuation Disputes

1. To initiate a swap valuation dispute notice amendment, click on Filing Index and select the dispute notice that you wish to amend.

3. You will be directed to the filing form, from which you can change the fields that you would like to amend. Here the initial margin, variation margin, and portfolio swap valuation dispute form is shown. Please note that the users should only amend the dispute amount, unless there are errors in the original filing.

Follow the same process to amend transactional dispute notices. If amending a transactional dispute notice, you may amend the dispute amount, notional value in USD and notional base currency, in addition to correcting any errors.
